Whilst the calendar is consistent with this principle, in practice in such cases it is best to make payment on the last working day prior to such deadline as electronic systems do not always automatically adjust for this.

It covers corporate and individual income tax, withholding tax, PAYE, SDL, WCF, NSSF, PSSF, VAT and Excise duty. There are a number of other taxes and fees, payable to central or local government, which have not been included. January

The Namib ("the land of open scapes") desert is thought to be the world's oldest desert (around 55 million years old). Located in Namibia, an interesting fact is that although it is devoid of surface water, thick fogs are common (as a consequence of the eastern part of the desert meeting the Atlantic ocean) and are the desert's lifeblood providing enough moisture for a variety of animal species to thrive. "Dune 7" (388 metres) is the tallest dune in the Namib. Sossusvlei, a landscape of undulating rusted orange coloured dunes, is home to the famous "Dune 45" (top left, 170 metres tall) and the "Big Daddy" (350 metres tall). Top right is a photo of the part of the desert floor from Dune 45 and bottom left is the "Deadvlei", located below Big Daddy and which is a clay pan with dark dead camel thorn trees (estimated to be 900 years old and which have not decomposed due to the dry climate). "Solitaire" (bottom right) is the very apt name for a small settlement (consisting of a petrol station, a shop, a chapel, a bakery and a lodge and campsite) located between the Sossusvlei and the coast at Walvis Bay, and at the crossing of two important roads, and well known for its the abundance of car wrecks.

February

The Kilimanjaro Marathon, which attracts significant numbers of participants both local and international, celebrated its 20th anniversary on Sunday 27 February 2022. The atmosphere leading up to the race was very vibrant with the city of Moshi packed with diverse visitors and with an array of entertaining activities throughout the race weekend. Having not previously participated in a 21 km race, it was a test of both my physical and mental endurance.

The race to the finish line felt like a never-ending journey; however, the level of accomplishment I felt upon completing the race was unparalleled. It's an occasion everyone should experience at least once in their lifetime and one that I would gladly redo again. The picture on the left shows trees (a species called "hagenia abyssinica") colliding in the centre in order to get sunlight (a term called "phototropic", with "phototropism" defined as the growth of an organism in response to a light stimulus.).

On the right is "Daraja la mungu" (so named by the locals due to the traditional beliefs) which is a large natural bridge that connects the two banks of the Kiwira river. So what did I learn from the visit? Well, for one to succeed in life you must aggressively take on challenges; secondly, this natural beauty was proof to me of God's existence. Visit Mbeya, and listen to the stories and then see what's your take.

In 1840 the Omani Sultan Seyyid Said moved the capital of his empire from Muscat to Zanzibar. There he mandated the establishment of clove plantations after realizing the conduciveness of its tropical climate and rich soils for growing a range of spices. At that time, spices were considered one of the most valuable commodities, sometimes rivaling gold. Indeed, it was the spice trade that essentially initiated globalization by helping form an international economic network from Asia to the Middle East to Europe, setting the trail for other commodities to follow. With increased spice production, Zanzibar became renowned as the world's "Spice Islands" - so much so, that a spice tour is a "bucket list" item for any tourist visiting Zanzibar. Other than being an integral part of our rich history, the importance of spices globally includes their taste enhancing properties, health benefits and food preservation properties. As the demand for spices increases world-wide, Tanzania has the opportunity to provide sustainable spice production. They say sitting on a throne is a thousand times harder than winning one! At the Bujora Cultural Centre in Mwanza lies an architectural marvel named the 'Royal Pavilion'. It depicts an "Isumbi" (the Kisukuma word for "stool"), being the Sukuma Chief's royal throne which is the ultimate symbol of power. The Pavilion, acting as a structure for displaying the royal regalia, provides the history of several chiefdoms and apart from the royal throne also has an upper story housing the royal drums. The museum's context takes you through a journey of the traditional Sukuma life: it starts with their major economic activity of iron workmanship by traditional blacksmiths 'Balongo'; it continues with their dwelling's structures with vernacular design, as well as the "Iduku", being their traditional doctor's house having objects used by healers, and their ancestral shrines. I also experienced how they performed their entertainment through the royal game, 'Isoko' and the venue composition for the dance battles between the Bagika and Bagalu societies. We may speculate that someday, people will visit ideas instead of places, but why not get the best of both worlds? Come visit a royal spot with a difference; the experience of this exotic location will certainly add a pinch of "masala" to your diversity experience.

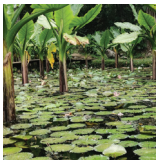
November

I remember asking myself how it manages to survive so well on its own, while in contrast and despite my best efforts my well watered flowers at home were wilting. Nature knows best, I suppose.

December

The Seychelles National Botanical Gardens, located at Mont Fleuri, on the outskirts of the capital city Victoria, have a variety of must see attractions including the biggest and heaviest nut in the world - coco de mer. On the left is a sculpture of the Five Rams. The original statue, built in 1960, is located in Yuexiu Park in the centre of Guangzhou ("City of the Five Rams"). According to Chinese belief, many years ago during a famine in Guangzhou, five celestial beings each riding a ram distributed stems of rice to the people, following which they left but the five rams stayed and changed into stones. The sculpture is believed to convey good wishes for the prosperity of the country and its people. On the right is a water lily pond. Water lily is a freshwater plant with floating leaves (lily pads) and showy flowers. Apart from medicinal use (roots used for a dry throat), the pads provide shade so keeping the water cool and preventing the growth of algae. They also protect fish from the heat of the sun and from predatory birds.
